The odd couple: infrastructure, marketing campaign DOE funding addresses two different types of contracting availabilities Efforts to increase the use of higher ethanol blends of fuel and support for development of domestic renewable fuels will mean

## Department of Energy has \$5.5 million in Recovery Act funds to distribute through multiple awards for the two separate projects.

The first project addresses infrastructure and has \$3.5 million to be awarded. Some 15-30 awards of between \$50,000 and \$200,000

per project are expected to be granted to projects such as upgrades to existing dispensing infrastructure, addition of new dispensing infrastructure, modifications or replacement of underground storage tanks or addition of increased storage capacity for ethanol or ethanol blends at retail stations. Any project that includes electronic card readers with updated product codes to track the amount of ethanol dispensed will receive higher consideration for receiving funding.

FirstEnergy Corp., based in Akron, is seeking \$114 million in smart grid technologies to improve the reliability and interactivity of its

high-tech computer system and digital technology to update its existing power grid. In Connecticut, some of the funds would be used to

electric distribution infrastructure in Ohio, Pennsylvania and New Jersey. Missouri hi-speed projects could mean variety of contracts The Missouri Highways and Transportation Commission is hoping to claim some of the \$8 billion in Recovery Act funding set aside for nationwide high-speed rail projects. The agency has approved 11 rail projects totaling \$201.3 million as part of its five-year

transportation plan. If the projects are funded, contracting opportunities could result from projects that include \$50 million in new locomotive and coach equipment, a new \$33.8 million bridge over the Osage River, \$3.6 million in upgrades to 13 crossings and the

closing of two and \$3 million for installation of displays at eight intermediate stations to provide train status information.

Additional funding is being made available from the American Recovery and Reinvestment Act (ARRA) for cleanup efforts of

brownfields, or contaminated sites. The U.S. Environmental Protection Agency (EPA) will award an additional \$55 million for these cleanup efforts in the form of revolving loans and subgrants to communities for cleanup, redevelopment projects and job creation near

## Brownfields cleanup efforts to benefit from \$55M in funds

brownfield sites. Some \$42 million of the total is being funded by the Recovery Act and \$13 million is coming from the EPA Brownfields funding program. The revolving loan funds provide low or no interest loans for brownfield cleanups. A total of 42 grantees will receive this supplemental funding from ARRA funds and another 18 from the EPA fund. The funding was awarded on a recipient's ability to deliver programmatic results by making at least one loan or subgrant and having effectively utilized existing loan funds, those with shovel-ready projects that

will result in job creation quickly and those with an ability to track and measure their progress in creating the jobs associated with loans

Airports to purchase inline baggage handling systems Three major airports, two of them in Hawaii, will share \$42 million in Recovery Act funding and will be seeking vendors to construct new inline baggage handling systems at their respective facilities. Administered by the U.S. Department of Homeland Security, funding will go to the Sacramento International Airport, Honolulu International Airport and Kahului Airport. The inline explosives detection systems are aimed at not only strengthening airport security by

Funding of \$11 million will go to the Sacramento International Airport to replace its stand-alone screening units in its B terminal with an inline baggage handling system. Honolulu International Airport will get \$24 million for an explosive detection system and the Kahului

and repair or replacement of inefficient heating and cooling systems will be paid for in **Texas** from \$328.4 million in Recovery Funds being awarded through the Texas Department of Housing and Community Affairs. Sixty-six cities, counties and nonprofits will benefit from the funding that will be used to weatherize the homes of approximately 40,000 low-income Texans. The funds will create

Renovations and energy upgrades at **Arkansas** colleges and universities, the state prison system and other state buildings will be paid for from \$69 million in stimulus money. Six million of that will go to the Hot Springs School for Mathematics, Sciences and the Arts to repair residential facilities there if the school will supplement the funds. A total of \$42.4 million will go to the state's colleges and

Construction and renovation projects that include caulking, weather-stripping, installation of ceiling, wall and floor insulation, duct work

**North Dakota**. The improvements will allow increased production by nearly one-fifth. The walleyes are used for stocking waters in eight states.

Probably not too many pond liner vendors expected business from the American Recovery and Reinvestment Act. But nearly \$1 million has been allocated for just that purpose. The funds will purchase pond liners for the federal government's walleye hatchery in Bismark,

\$700,000 has been allocated to replace a water main. Projects in Waseca, Kandiyohi, Wheaton, Blue Earth, Elbow Lake, Swanville and Remer also will benefit from low-interest loans and principal-forgiveness grants. Construction and repair contracts are resulting from \$2.3 million in economic stimulus funds awarded to the U.S. Army Soldier Systems Center (Natick Labs) in Natick, **Massachusetts**. Projects and the amounts allocated include: repair sewers - \$45,000; replace

heating systems - \$100,000; replace windows, \$100,000; repair roadway - \$1.9 million; exterior repairs to U.S. Navy Clothing and

infrastructure. Of that amount, \$107 million is from the American Recovery and Reinvestment Act. In the community of Hoffman alone,

Minneapolis to St. Cloud would garner the largest portion of the funds at \$150 million. Another \$137 million is being sought to design and construct a multimodal transit hub at the St. Paul Union Depot, with \$50 million for engineering and design work for a high-speed passenger line connecting the Twin Cities, Milwaukee and Chicago. A line connecting Minneapolis to Duluth, the Northern Light

numerous construction jobs. Facility renovations are part of the numerous projects scheduled for 16 federally qualified health centers in **Arizona** being funded by the Recovery Act. The more than 100 medical and dental clinics in the state will share in \$25.6 million in federal funds.

universities while state agencies, including the Department of Corrections, will garner \$26.6 million.

Clothing and school supplies for homeless children will be purchased with 17 grants awarded to **Colorado** school programs. These two items are among a number of expenditures the more than \$900,000 in Recovery Act funds allocated to schools by the Colorado Department of Education.

Eight **Minnesota** communities will use \$27.3 million in grants and loans to build or upgrade drinking water and wastewater
